Andhra Pradesh Public Employment (Regulation of Age of Superannuation) (Amendment) Act, 2024 (ACT No. 13 of 2024) published in the Andhra Pradesh Gazette Part—IV-B Extraordinary, No.13, Amaravati, dt.29.11.2024.

ORDER:

In the Act published in reference read above, an Act namely, Andhra Pradesh Public Employment (Regulation of Age of Superannuation) (Amendment) Act, 2024 (ACT No. 13 of 2024) has been notified in the Gazette. According to the aforementioned Act, the following amendments have been issued to the Andhra Pradesh Public Employment (Regulation of Age of Superannuation) Act, 1984:-

- 1.(1) This Act may be called the Andhra Pradesh Public Employment (Regulation of Age of Superannuation) (Amendment) Act, 2024.
- (2) It shall be deemed to have come into force on the 1st November 2024.
2. In the Andhra Pradesh Public Employment (Regulation of Age of Superannuation) Act, 1984, (hereinafter referred to as the Principal Act), in section 3(1A),
 - (1) In the Andhra Pradesh Public Employment (Regulation of Age of Superannuation) Act, 1984, in section 3, in sub-section (1A), for the words “sixty years”, the words “sixty one years” shall be substituted.
3. The concerned administrative department of the Secretariat shall take necessary action to implement the provisions of the above Act immediately.
