2. In the reference 3rd read above, Sri K. Venkateswarlu, Senior Assistant Public Prosecutor has been promoted as Additional Public Prosecutor Grade-II, in terms of Rule (10) (a) of A.P. State & Subordinate Service Rules, 1996.

3. In the reference 4th read above, the Director of Prosecutions (FAC), A.P., has submitted proposals for the postings of Additional Public Prosecutor Gr.II, except Sl.No.1 from the cadre of Senior Assistant Public Prosecutor whose names were approved by the Government.

4. Accordingly, in terms of Rule (10) (a) of A.P. State & Subordinate Service Rules, 1996, Government hereby promote Sri.K.Rama Krishna, Senior Assistant Public Prosecutor as Additional Public Prosecutor Grade-II, with immediate effect.

5. The promotion ordered in para (4) above is purely temporary and is liable for reversion to the lower post at any time without assigning any reason therefor and subject to outcome of any Court cases pending, in the matter, before the Tribunal and Courts.

6. On his promotion, Sri.K.Rama Krishna, is posted as Additional Public Prosecutor Grade-II, at I Additional Assistant Sessions Judge Court, Kakinada as there is clear existing vacancy.

7. The Officer promoted in para-2 above shall join in the promotion post within a period of 15 days from the date of receipt of the orders of promotion. If, he fails to join in the promoted post within the stipulated time or evades to join the post by proceeding on leave, he shall forfeit his right of appointment both for the present and in future for his promotion post.

8. The Director of Prosecutions (FAC), Andhra Pradesh, Vijayawada, shall take necessary further action in the matter.
