1.	Referred Trail	Rs. 5,000/- (Rupees five thousand only) per case.
2.	Criminal Appeal (Bench)	Rs.4,000/- (Rupees four thousand only) per case.
3.	Criminal Appeal (Single Judge)	Rs.3,000/- (Rupees three thousand only) per case.
4.	Criminal Revision Case	Rs.2,000/- (Rupees two thousand only) per case.
5.	Criminal Petitions/ Interlocutory Applications	Rs.1,000/- (Rupees one thousand only) per case.
6.	Criminal Revision Case Interlocutory Applications	Rs.1,000/- (Rupees one thousand only) per case.
7.	Legal opinions/ Grounds of Appeal	Rs.1,000/- (Rupees one thousand only) per case.
8.	Transfer Criminal Petition	Rs.1,000/- (Rupees one thousand only) per case.
9.	Criminal Appeal Interlocutory Applications	Rs.1,000/- (Rupees one thousand only) per case.
10.	Retainer Fee	Rs.25,000/- (Rupees twenty five thousand only) for Public Prosecutor and Rs.20,000/- (Rupees twenty thousand only) for Additional Public Prosecutor.
11.	Conveyance Allowance	Rs.25,000/- (Rupees twenty five thousand only) for Public Prosecutor and Rs.20,000/- (Rupees twenty thousand only) for Additional Public Prosecutor.
